NOW, YOU MUST FOLLOW THESE STEPS WITHIN 30 DAYS OF TODAY'S DATE IN ORDER FOR THE STATE OF MISSOURI TO PROCESS YOUR APPLICATION.

HAVE THE FOLLOWING DOCUMENTS READY TO SCAN:

- 1) PATIENT REGISTRATION (THIS FORM YOU ACTUALLY INPUT INTO THEIR SYSTEM) \$25
- 2) PHYSICIAN CERTIFICATION
- 3) CAREGIVER REGISTRATION FORM (IF APPLICABLE) \$25
- 4) PATIENT AUTHORIZATION, IF YOU WILL HAVE A CAREGIVER
- 5) CULTIVATION FEE \$100. IF YOU HAVE CHOSEN THIS OPTION, YOU MUST ADD THE DESCRIPTION OF HOW THE PATIENT'S CULTIVATION FACILITY COMPLIES WITH THE DEFINITION "ENCLOSED, LOCKED FACILITY," IN CSR 30-95.010), DETAILS ON HOW MANY PLANTS WILL BE GROWN IN ONE FACILITY AND THE NAME AND THE TITLES OF THE PATIENT OR CAREGIVER WHO MAY HAVE ACCESS TO IT.
- 6) A CREDIT CARD TO PAY APPLICABLE FEES.
- 7) A VALID MISSOURI DRIVER'S LICENSE OR ID CARD OR A COPY OF A CURRENT MOTER VEHICLE REGISTRATION OR A COPY OF A RECENT UTILITY BILL.
- 8) A CURRENT PICTURE OF YOURSELF.
PLEASE UPLOAD A PHOTO OF YOU THAT IS SQUARE AND PROPERLY ORIENTED. SIDEWAYS OR RECTANGULAR PHOTOS WILL BE REJECTED. ALSO, PLEASE ENSURE THE IMAGE IS A CLEAR COLOR PHOTO OF THE APPLICANT'S UNOBSURED FACE TAKEN WITHIN THE LAST 3 MONTHS TO REFLECT THE APPLICANT'S CURRENT APPEARANCE WITH A PLAIN WHITE OR OFFWHITE BACKGROUND. THE APPLICANT MUST BE DIRECTLY FACING THE CAMERA AND SHOULD HAVE A NEUTRAL FACE EXPRESSION OR NATURAL SMILE WITH BOTH EYES OPEN. YOU CANNOT HAVE A HAT ON OR ANY SUNGLASSES ON. GENERALLY, THE PHOTO SHOULD LOOK LIKE THE DRIVER'S LICENSE OR PASSPORT PHOTO. THE FILE MAY NOT BE DIGITALLY ENHANCED OR ALTERED IN ANY WAY THAT CHANGES THE APPLICANT'S APPEARANCE. PHOTO'S THAT DO NOT ADHERE TO THESE REQUIREMENTS WILL BE REJECTED.

IF YOU DON'T HAVE ACCESS TO A CELL PHONE WITH THESE CAPABILITIES, OR A COMPUTER, PLEASE ASK A FAMILY MEMBER OR FRIEND FOR ASSISTANCE. OTHERWISE, GO TO YOUR LOCAL LIBRARY.
